
South-Point Constructors is a fully-integrated joint venture between Kiewit Infrastructure South Co. and Austin Bridge & Road.






#### PROCUREMENT TIMELINE

  - Added sidewalks and shared use path








Additional capacity shown with red arrows.







- Added sidewalk or shared use path











- Added capacity on mainlanes and frontage roads

- Increased mobility with Texas turnarounds and ramps












## **PROJECT ELEMENTS**

Sidewalk/Shared Use Path (SUP) is to be constructed along all frontage roads/cross streets providing bicycle and pedestrian mobility for the entire corridor

- Only 7,000 SY of current sidewalk throughout the project corridor
- Improvements
  - 110,000 SY of new Sidewalk/SUP
  - Approximately 19 miles














## I-820: US 287 TO RAMEY AVE.

#### Early March to Late Summer/Early Fall

- Maintain mainlanes capacity on I-820 during the day, lane restrictions at night
- Build temporary mainlanes, frontage road, walls, barrier and signage






## I-820: US 287 TO RAMEY AVE.

#### Late Summer through Late 2023/Early 2024

- Frontage roads reduced to one lane (2 lanes at intersections)
- I-820 mainlanes to be constructed in center median, then northbound, then southbound
- Alternating side street closures at frontage roads
- Begin driveway construction. Alternating driveways or half at a time

(Full width frontage roads and driveways at conclusion of Phase 1)






## **VILLAGE CREEK RD. ALIGNMENT**

# Early March into Late Summer/Early Fall

- Maintain mainlanes capacity on US 287 during the day, lane restrictions at night
- Begin reconstruction of Village Creek Rd. intersection and bridge. (Complete reconstruction of intersection to be signalized when complete)
- Build temporary mainlanes, frontage road, walls, barrier and signage
- New frontage road construction from Wilbarger St. to Carey St., and at Martin St., west of I-820






## **VILLAGE CREEK RD. ALIGNMENT**

### <u>Late Summer through Late</u> 2023/Early 2024

- Frontage roads reduced to one lane (2 lanes at intersections)
- Begin driveway construction.
  Alternating driveways or half at a time
- Mainlanes to be constructed in center median, then northbound, then southbound






## I-820: SUN VALLEY DR. TO I-20

#### Early March into Late Summer/Early Fall

Begin rebuilding Sun Valley Dr. frontage roads

#### Late Summer through Late 2023/Early 2024

Continue Sun Valley Dr. frontage road work






## I-20: FOREST HILL DR. TO ANGLIN DR.

#### Majority of 2023

- Begin reconstruction of Hartman Rd. intersection (Not pictured)
- Closure of Hartman Rd. at I-20 (Not pictured)
- Rebuild frontage roads
- Utility relocations






# I-20: ANGLIN DR. TO BOWMAN SPRINGS RD.

#### Early March into Late Summer/Early Fall

- Begin westbound I-20 bridges in center median
- Begin temporary frontage road pavement and new Bowman Springs Rd. bridge
- Build temporary pavement and widening for Business 287 (Not pictured)



# I-20: ANGLIN DR. TO BOWMAN SPRINGS RD.

#### Late Summer through Late 2023/Early 2024

- Build westbound I-20 frontage roads, frontage road bridges and collector distributor
- Frontage road expansion at Business 287 (Not pictured)




- Begin bridge work and temporary pavement in medians
- Utility relocations







# **US 287: LITTLE RD. TO SUBLETT RD.**




